Through the third-party judging and certification of spring water distributed in Japan and water-related products and services such as stores, our aim is to improve the branding of products. The Award activities are disseminated through a wide variety of media. This will Increase interest in high-quality water, and provide an evaluation that the award-winning products, producers and salespeople can be proud of.

Application requirements

Award intended for:

• Applications for the Japan Aqua Awards (JAA) are available for spring water distributed in Japan.

• Applications can be submitted by water sampling specialists, producers (bottling companies), importers, exporters, wholesalers, sales organizations, and local governments.

• You can enter unimported spring water, but JAA does not import it.

• The entries for Still and Sparkling are different. If you enter both Still and Sparkling, the entry sheet will be different. Therefore, each examination fee is also required.

• One application can be used for multiple products.

- Please submit the entry form, and provide a sample for each product being applied for.

Send 24 units of each product (because the preliminary evaluations will be made by more than 10 judges, 24 units has been specified, see details).

- Please send 24 units if the volume is 500ml or less; 12 units if over 500ml.
